## **Reminder of Covenants**

Even though a recently passed Georgia law changes some requirements for small-scale outdoor burning, River's Edge's covenants prohibit open fires unless they are in a fire pit with a covered top.

The new law, however, did not change the absolute liability to anyone who causes

any damage to adjacent properties. If you are new to River's Edge and wish to obtain a copy of our covenants, please contact Linda. River's Edge has always had covenants, and when you purchased your property, you did so subject to the covenants.

## Dogs.....again

The most complaints we receive, are about dogs that are not kept on leashes. As we have previously reported, Gilmer County Animal Control is the authority that enforces violations. Please make sure your dog is under control at all times, to avoid any complaints. PLEASE continue to be considerate of your neighbors, as you enjoy your pets.

### We Have Bears!

There have been several reports of spotting bears on Mountain Springs Circle, Orchard Lane and Lazy River Lane. There have also been bears seen in Blackberry Mtn. Some are young bears, but one bear was estimated at 400 pounds. We know there are residents who feed the deer. Yes, we know they were here first, however, Animal Control reports that any food is an attraction for the bears. Bears have been reported to climb up decks to retrieve food put out for other wildlife, or food you have left unattended for your pets.

## Contractors/Service Workers

Please make sure your contractor/service workers do not park on our water lines. Some of the heavy trucks will damage, sometimes break, the lines. If you don't know where the lines are located, contact Linda, she will have our Water Manager advise you. Our water and wells are our most precious resource, and we need to be on guard to protect them.

Also, remember No Construction work should be done on Sundays, unless it's an emergency.

### Blackberry Mountain is also Firewise

We are pleased to announce that Blackberry Mountain has joined River's Edge in becoming a certified Firewise Community. This makes five communities in Gilmer County that are actively working on lessening their fire threat. Obviously, a fire in Blackberry would create a huge danger of spreading into River's Edge.

We congratulate them on achieving this certification, as we all work together to lessen this ever present threat to our beautiful mountains. The Georgia Forestry Commission responds to more than 3,500 wildfires each year. Escaped debris burning is the number one cause of wildfire in Georgia.
