## REMINDERS FROM THE BOARD

## **EVERY DAY THIS BECOMES MORE IMPORTANT!**

Devastating wildfires have erupted in California and the East Coast. Now North Carolina, South Carolina and Georgia are being targeted by these fires! Everyday we become more concerned that our cozy little community could be next. We are prime fire country with our beautiful forests, dead and down trees and lack of good rain! While we do not have the Santa Ana winds, one fire and wind like we have had in February and March in our wooded community could create havoc and could cost us our homes and our lives! Many in our community have been thinking about what we need to do to eliminate the possibility of it happening here. To that end, the Board is requesting that ALL landowners (the ones living here, second homeowners, and the ones who just have property here) evaluate their property and get rid of dead standing and downed trees and debris. We know that this might not be an easy task if you have not kept up with your cleanup, but it is imperative that all landowners do their fair share to keep our community as safe as possible so we do not have a fire happen here! To those landowners who have been working at this all along, the task won't be so bad---but there are many vacant lots, adjacent lots, and wooded areas behind our homes that have not been touched in years. You probably have seen Carlos and his crew here a lot in the last month—people are starting to take down those dead trees but we need everyone to do it!! If you have any questions or need phones numbers of companies that have done a good job in our neighborhood, please contact one of our Board Members. Let's make this a spring to remember by cleaning up and not burning up!!

## **SPRING CHIPPING!!**

Spring Chipping for River's Edge has been scheduled for the week of April 28<sup>th</sup>. We are not sure what days Carlos will be here, since weather conditions can affect his schedule. We ask that you do not include anything with a diameter over 8" on the largest end or anything longer than 10' in length. We need to keep our roadways clear for vehicle traffic and pedestri ans, with that in mind, please stack your debris off of the roadways with all the branches and trunks laying in the same general direction.

The homes in our community have started to sell once again and we have several new residents, so I thought I should remind everyone of some of our rules and regulations:


- 1. No short term rentals. If you do rent your home, it must be for six months or longer.

  And remember, you are responsible if your renter breaks our community rules. Anyone engaged in short term rentals will be fined up to \$500 per day.
- 2. Our By-laws/CCR's state that fees are due on the 1<sup>st</sup> day of the first month of each quarter (January 1, April 1, July 1, and October 1). Please help us by mailing your checks early enough for them to arrive early or on time. Payments received after the due date are subject to late fees and interest in accordance with the Bylaws and CCR's.
- 3. Please remember that new construction, additions/changes to existing homes and garages, large landscaping projects and changing the color of your home needs to be approved by the Architectural Committee consisting of Phillip Teagarden, Jim Carr and Esther Lax. For all questions as to whether you need approval or how to fill out the forms, please contact one of these committee members and they will be glad to help you. For the approval forms that need to be filled out, please contact Jeannie Miller at the HOA office.
- 4. Just a reminder when evaluating your spring projects, as of January 1, 2022, the road impact fee was updated to include large renovations and other improvements to your property. This includes the addition of a garage or additional space to your existing garage, addition to your home and it could include large yard work if heavy trucks and equipment come in with supplies and/or do the work. The purpose of the impact fee is an effort to put aside the money for road improvements when they are needed.

SPRING IS HERE And we have been inside for a long time! We are itching to just get out there and do something to our homes and yards! But remember, our water system is fragile. Just one property that decides to fill their hot tub or pressure wash their home could use all the water in your well. Not only will you be out of water, your neighbors will be out of water also!!! Remember that there are companies that will haul water in to fulfill these needs, you need only ask. If you want to create your own rainwater system, Tom has provided us with a diagram of a water system we can create. This won't be enough water to pressure wash your house or fill your hot tub, but you can water your plants this spring and summer or wash your car!

Now that the weather is warming up a bit it's a good read for anyone planning on painting, using gas powered equipment, grilling, etc. Only one tip per topic is included in this writeup. ## \*\*\*Properly use and store gasoline

- Never store gasoline containers in a basement or in the occupied space of a building.
- Keep them in a detached garage or an outdoor shed.

\*\*\*Carefully dispose of rags with paint and stain. The oils commonly used in oil-based paints and stains release heat as they dry. If the heat is not released in the air as the rags dry, the heat is trapped, builds up and can cause a fire.

• Never leave cleaning rags in a pile. When you're finished using the rags, take them outside to dry, keeping them well away from the home and other structures.

### \*\*\*Use/store flammable and combustible liquids with care

 Keep liquids in their original containers. Keep them tightly capped or sealed. Never store the liquids in glass containers.

## \*\*\*Inspect grills to ensure they're in good working order

 Inspect your grill carefully and make sure it's free of grease or fat buildup. Clean out any nests, spider webs, or other debris you may find.

### \*\*\*Keep debris well away from your home

Every year, <u>wildfires</u> burn across the U.S., with more and more people living in communities where wildfires are a real risk.

• Remove dead vegetation and other flammable materials, especially within the first five feet of the home.

## \*\*\*Clean out vour clothes drver

 Make sure the air exhaust vent pipe for your <u>dryer</u> is not restricted and that the outdoor vent flap will open when the dryer is operating. This includes making sure the outdoor vent flap is not covered by snow.
